संख्या प.15(च)/एफएफसी/डीएलबी/20/414:-14वें वित्त आयोग की जनरल परफोर्मेंन्स ग्रान्ट के संबंध में प्रस्तुत की गई बाध्यकारी सिफारिश 9.75 के अनुसरण में राज्य की समस्त नगर पालिकाओं द्वारा मूलभूत सेवाओं के लिये सेवास्तरीय बेंचमार्कों का निर्धारण करना एवं उनको प्रकाशित करना अनिवार्य किया गया है।

उपरोक्तानुसार राज्य में स्थित 193 नगरीय निकायों द्वारा ठोस कचरा प्रबन्धन, स्ट्रोम वाटर ड्रेनेज एवं सीवरेज एवं सेनीटेशन के संबंध में सर्विस लेवल बेंचमार्किंग वर्तमान स्थिति तथा वर्ष 2020-21 के लिये लक्ष्य निर्धारित किया गया है। इसी प्रकार राज्य में स्थित समस्त 193 नगरीय निकाय क्षेत्रों के लिये वाटर सप्लाई से संबंधित बेंचमार्कस (वर्तमान स्थिति एवं वर्ष 2020-21 लक्ष्य निर्धारण) का निर्धारण जनस्वास्थ्य अभियांत्रिकी विभाग द्वारा किया गया है।

अतः राज्य सरकार नगरपालिका अधिनियम, 2009 की धारा 45,46 एवं 337 के अन्तर्गत प्रदत्त शक्तियों का प्रयोग करते हुए उक्त सर्विस लेवल बेंचमार्क को एतद् द्वारा अधिसूचित करती है।
